The aim of the Bulgarian webinar was to share the accumulated experience about the web-based <u>Triple-A Tools</u> for evaluation of energy efficiency projects, which are at an early stage of implementation.

This webinar focused on the **risks to energy efficiency projects and mitigation strategies**, the online-based <u>Triple-A Tools</u> for evaluating energy efficiency projects (Assess Tool, Agree Tool) and how energy efficiency projects are linked with appropriate funding mechanisms (Assign Tool).


Title: Energy Efficiency Financing Assessment Tools

<u>Triple-A</u> partner <u>IEECP</u> together with its sister projects <u>ICCEE</u> and <u>StreamSAVE</u> organised the training on "Energy Efficiency Financing Assessment Tools" that was held in the Dutch Language.

The aim of the training was to present the <u>online assessment Tool</u> developed and utilised within the Triple-A project to facilitate the financing of energy efficiency investments in the European Union. A discussion took place on the national context of the **most prominent policies** relating to energy efficiency projects, including their **financing opportunities**.

The objective of the workshop was to present to the audience the **Energy Efficiency Financing Assessment Tool** which was elaborated during the **Triple-A** project and was intended towards financial institutions and other entities related to the implementation of energy efficiency projects.

The topics covered during the training workshop included introduction of the **Triple-A** assessment tools, key **recommendations** to assessment process on what energy efficiency investments are realistic and feasible in the country context, means of financing the projects in practice in the short or medium term, **financing methods** and approaches, evaluation and verification of the results.

Title: Valutazione e finanziamento di progetti di efficientamento energetico

Participants had the opportunity to enjoy a live demonstration of the Standardised Triple-A Tools and Database that would facilitate investments into Energy Efficiency, which is considered of outmost importance for the achievement of the EU's energy and climate objectives.

The current status of the national context in the Energy Efficiency sector was presented, including financing opportunities, by highlighting the availability of financial resources to accelerate growth, after the launch of the Next Generation EU (NGEU) program in 2020 (better known in Italy as the Recovery Fund). These resources are used by the Italian government within the PNRR (National Recovery and Resilience Plan) to provide financial aid to entities interested in a green and sustainable transition.
